5. The eligible bidders shall submit registration form, VAT and tax registration form with tax clearance certificate of previous fiscal year and other necessary documents with the Sealed Quotation.

Quotations must be valid for a period of **45 days** after opening of Sealed quotations and must be accompanied by Cash Security or Bank Guarantee, amounting to a **minimum of 2.5 % of the quoted amount (inclusive of VAT)**, which shall be **valid for 75 days** after opening of the Sealed Quotations for both packages separately.
7. If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No. **00100105201107** at **Everest Bank Limited, Baneshwor Branch** and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
8. Sealed Quotations shall be opened in the presence of Bidders' representatives who choose to attend at **[14:00 PM, 2068-07-21]** at the office of **Jalabidhyut Lagani Tatha Bikash Company, Babarmahal Kathmandu**.
9. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day.
